Cover

- Fire / Lightning / Storm / Water / Hail / Snow

- In-transit to shearing location (fire / collision / overturn – R50 000)
 - Fire extinguishing costs & debris removal (only with regards to Transit)- R10 000
- Included is coverage for lambs at 12% of calculated loss – Coverage is limited to R250 per lamb.

Important information

- All shearable sheep must be insured
- Cover is renewed annually
- Excess payments are applicable as defined in the policy wording
- Tariff – NWGA members 0.26%. Non-members 0.52% (annually)
- The current tariffs are based on participation of 5 600 000 sheep and will be revised in February 2017.
